2) Attendance by proxy

2.1) In the case that the shareholder wishes to appoint a proxy to attend and vote at the meeting on her/his/its behalf, the said shareholder must complete the Proxy Form enclosed to this invitation and submit the said Proxy Form together with the following documents to the Company's officers:

- 2.1.1) In case the shareholder is a natural person: (a) a copy of an I.D. card or a government officer I.D. card, or a state enterprise employee I.D. card, or a driver's license (in case of a Thai person); or a copy of Certificate of Alien, or a passport, or a document used in substitution of passport (in case of a foreigner), which has not expired and certified true and correct copy by the shareholder; and (b) an I.D. card, or a government officer I.D. card, or a state enterprise employee I.D. card, or a driver's license (in case of a Thai person); or a Certificate of Alien, or a passport, or a document used in substitution of passport (in case of a foreigner) of the proxy.
- 2.1.2) In case the shareholder is a juristic person: (a) the Affidavit of such juristic person issued by the Department of Business Development, Ministry of Commerce, for a period of no longer than 6 months before the meeting date (in case of a juristic person registered in Thailand); or the Affidavit of such juristic person (in case of a juristic person registered outside Thailand); and (b) an I.D. card; or a government officer I.D. card; or a state enterprise employee I.D. card; or a driver's license (in case of a Thai person); or a Certificate of Alien, or a passport, or a document used in substitution of passport(in case of a foreigner) of the proxy.
- 2.2) Each Proxy Form must be affixed with stampduty for the value of Baht 20. In the event that more than one person is appointed as proxy, additional Baht 20 stamp duty must be affixed for each additional proxy.
- 3) All photocopies must be certified true and correct copy by the shareholder, on each and every page of the photocopies. In the case of document produced or executed outside Thailand, such documents must be notarized by a notary public of not more than 1 year before the meeting date.
